Transmitting herewith for your appropriate action, the result of our investigation with the recommendation that **THOMAS MICHAEL RUHLAND a.k.a. "MIKE"**, a DEUTSCH national, born on August 1, 1972, with passport number 864002604, ^{a resident of San Valley, Guadalupe, Cebu.} be charged and prosecuted for in an inquest proceeding for Violation of Sec 6 (a) of RA 9208 (Anti-trafficking in Persons Act of 2003), Violation of Sec 9 and 10 (a) of RA 7610 (Special protection of Children Against Child Abuse, Exploitation and Discrimination) and RA 9775 (Anti-child Pornography Act).

Investigation disclosed that at around 11:30 in the morning of January 5, 2011, JENNY BARAN, a minor, born on March 23, 1996 and a resident of Lower Mojon, Talisay City and EVELYN TUNDAG ASINTISTA, of Dumlog, Talisay City, also a minor, born on April 22, 1994, met with THOMAS MICHAEL RUHLAND a.k.a. MIKE (MIKE for brevity) at Gaisano Tabunok for a photo modeling shoot for a pay of Php400 to Php 500 on every session. The trio then went to Pook Talisay Beach where MIKE took modeling pictures of JENNY and after the photo shoot, MIKE paid JENNY Php500.

On January 12, 2011, they met "MIKE" again at the same place and went near the Basilica of Sto Nino for another photo modeling shoot. After the session, MIKE again paid JENNY Php500.

Welche Evelyn?

In the morning of January 19, 2011, EVELYN informed JENNY that MIKE wanted to see her. They met again at the same place and MIKE brought them to Queensland Motel, Talisay City. There, MIKE instructed them to take a bath and to shave their pubic hairs. After that, MIKE instructed JENNY to remove her dress leaving only her bra and panty. Then after that, she was instructed to remove her bra and panty and posed nude in front of the camera. While JENNY was with MIKE, EVELYN was on the other side of the room. When MIKE was finished taking pictures, she instructed EVELYN to get out from the bigger room, both minors resisted but because MIKE was authoritative, EVELYN obeyed. MIKE then removed his clothes and pushed JENNY on the bed. He then placed himself on top of JENNY. She resisted but was overpowered by the strength of MIKE. MIKE then forcibly entered his penis into JENNY's vagina without her consent and on the motion of pumping that caused pain and bleeding to JENNY. After his bestial act, they went out from the room. While they were on board the vehicle, MIKE handed to JENNY Php400 as payment.



JENNY confided the incident to his father TEOFILO CATAYAS, JR so that the latter filed a complaint against the Subject MIKE before this office thus this investigation.

EVELYN TUNDAG ASINTISTA met MIKE two years ago. She was also photographed naked and was having sexual contact with him. MIKE requested her to invite friends or other Filipino girls who will be interested for a modeling shoot.

On February 2, 2011, JENNY was informed by EVELYN that MIKE wanted to see her. They met MIKE at Gaisano Tabunok and boarded to MIKE's car. MIKE brought them to room 24 of Queensland Motel located at Talisay City. At around 3:30 in the afternoon, she was surprised to see her father, TEOFILO CATAYAS, JR. (TEOFILO) together with other persons entered the room and rescued them.

On the same date, this office received an information from the father of JENNY that JENNY is meeting again with MIKE at Gaisano Tabunok. A rescue operation was conceived by Agent JEDIDAH HIFE to the sexually abused minor girls.

Acting in the information supplied by the father of JENNY, the NBI Operatives proceeded to Gaisano Tabunok with TEOFILO and waited for possible incident to happen. After waiting several minutes, things happened. JENNY and EVELYN were visible at the parking area. Minutes later, a Caucasian male arrived and opened the car with plate number GJN 111 and signaled the two minors to get inside.

As the Operatives followed MIKE's car discreetly, the car finally entered room 24 of Queensland Motel, Lawaan II, Talisay City.

Meanwhile, inside the room of Queensland Motel, JENNY posed nude again in front of the camera of MIKE wherein MIKE captured images of JENNY in nude.

The NBI Operatives who were waiting outside the motel for a right and good timing, slowly made their way inside to room 24 and fortunately as it happened, EVELYN got out from the room and the NBI Operatives took that chance and went inside to the just opened ingress of the room and then declared their authority.

In the presence of TEOFILO CATAYAS, JR, the father of JENNY, MIKE was caught in the act of taking pictures of JENNY in nude at the sofa of the ante room. He was equipped with video, a digital camera, tripod, and flood lights. Also seen at the room were several pieces of skimpy sexy lingerie in different colors, sandals and sexy dresses.

The minors were rescued and taken into custody and brought to the NBI office.

An arrest was made to THOMAS MICHEAL RUHLAND a.k.a. "MIKE". He was informed of the charges against him and his rights under our laws.

THOMAS MICHAEL RUHLAND was brought to the office of NBI for booking and documentation.

In view of the foregoing, it is respectfully recommended that THOMAS MICHEAL RUHLAND be prosecuted for Violation of Sec 6 (a) of RA 9208 (Anti-trafficking in Persons Act of 2003).

JOINT AFFIDAVIT

We, **REYNALDO C. VILLORDON, GREGORIO Y. ALGOSO JR., BERNARD A. DE LA CRUZ, TEODORO M. SAAVEDRA, JEDIDAH S. HIFE, FLORANTE T. GAOIRAN**, all Filipino, of legal ages and Agents and Special Investigators of the National Bureau of Investigation, respectively, and presently assigned with the NBI Central Visayas Regional Office, (NBI-CEVRO) after having duly sworn to in accordance with law do hereby state that :

This office took cognizance with the complaint filed by **TEOFILO CATAYAS JR.** of Lower Mohon, Talisay City against a certain **MIKE** for sexually molesting his fourteen (14) year old daughter, **JENNY BARAN** on January 26, 2011;

This case was assigned to me (**SI JEDIDAH S. HIFE**) for appropriate action:

Sometime in the morning of February 2, 2011, I (Hife) received an information from the father that subject, **MIKE** wanted to meet the victim, **JENNY** again at Gaisano Tabunok:

Anticipating that Subject wanted to take advantage again with the victim, our team was formed to monitor them and to arrest subject should evidence warrant;

At around 3:00 in the afternoon of that day, our team on board a white KIA van with plate No. SJW 410 met with the complainant at the parking area of Gaisano Tabunok and lucky enough to get a parking space just across the parked car of the subject, a silver toyota with plate no. **GJN 111** as pointed by the complainant;

After waiting for a few minutes at the parking area, **JENNY BARAN** together with another girl, identified later as **EVELYN MACASLING** (16 year old) came near the parked vehicle of the subject;

Few minutes later, a caucasian male in his late 30's also arrived and opened the car and signalled the two young girls to get inside.

The car driven by the caucasian male left the area and the team followed while keeping a distance to avoid detection;

The silver car ended up entering the parking space of Room 24 of Quen's Land Motel at Lawaan II, Talisay City;

As the car entered room 24, the team also entered the parking space of Room 25;

After about twenty (20) to thirty (30) minutes, the team rushed up to Room 24 and it also happened that **EVELYN**, was about to get out from the said room;

The NBI wait again! Why? The fact is given already that there is already RA 7610. Why they waiting 20-30 minutes? In another statement NBI say that they are in hurry to rescue the women. For what they are waiting?

JENNY at the sofa of the anti room;

Subject was equipped with video and digital camera with stand and flood lights while several skimpy lingerie were also found scattered at the bed;

Immediately, subject identified as **RUHLAND, THOMAS MICHAEL**, a German national was placed under arrest, handcuffed, informed of the charges against him and his rights under our laws while **JENNY** was guided to dress up;


Pictures of the vicinity of Room 24 were taken;

Subject together with the minor victims were brought to NBI office;


Subject was booked, fingerprinted and photograph. Subsequently, documents were prepared for the inquest of the the subject before the Prosecutor's Office in coordination with the Regional Task Force in Trafficking in person.

That through their conversations, I learned that BELEN has a GERMAN boyfriend named a certain MIKE.

That later on, my daughter asked permission from me that BELEN invited her to a photo modeling shoot to be taken by her boyfriend MIKE;

That I did not mind her at first because I thought it was just a wholesome picture taking considering that BELEN is also a minor;

That my daughter was able to take the photo shoot;

That on the third time of the photo shoot, my daughter confided to me that she was sexually molested by the foreigner photographer, MIKE. That MIKE took nude photographs at her and after taking the pictures, MIKE had sex with her. After MIKE used my daughter, he gave him a cellular phone and P400.00; Who is him?

That on January 26, 2011, I went to the office of the National Bureau of Investigation to file a complaint against the GERMAN foreigner named MIKE who sexually molested my minor daughter; Why NBI don't arrest me on January 26? NBI said, they know where im living.

That on February 2, 2011, while I was at work in Pooc, Talisay City, BELEN asked permission from me that she will bring my daughter in GAISANO TABUNOK located in Talisay City. After several minutes, it occurred in my mind and my instinct told me that the two girls might be meeting again with the German foreigner so that I immediately called Investigator JEDIDAH HIFE about it. After several minutes, Investigator HIFE called me that a rescue operation will be conducted by the elements of the NBI and I was told by her that I should cooperate whatever help I can be able give.

That MIKE was eventually arrested by the NBI. How? Explain it.

I, JENNY BARAN, Filipino, minor, 14 years old, born on March 23, 1996 and a resident of Lower Mojon, Talisay City, Cebu and a second year high school at Divino Amore National High School, Mojon, Talisay, Cebu, after having been sworn in accordance with law do hereby depose and say:

1. That I am the second child of TEOFILO CATAYAS, JR and MARCELINA BARAN; *Teofilo Catayas ist nicht ihr Vater.*
2. That I met MIKE through EVELYN TUNDAG ASINTISTA (EVELYN). I know EVELYN because her elder brother rented a room in our house and she sometimes stayed with her brother. Her mother is from Dumlog, Talisay, Cebu. Their was a time when I go with EVELYN and MIKE during a photo shoot then after a photo modeling shoot. MIKE handed Php500.00 to her;
3. That in the morning of January 5, 2011, EVELYN told me that MIKE wanted to see me. The purpose of such meeting is to take pictures and will be paid for Php 400 to 500 each session. She told me that we will meet with the foreigner at Gaisano Tabunok at around 11:00 to 12:00 noon; *Da war ich beim Stammbisch im Kaufhaus Ayala Evelyn bring Jenny.*
4. That because I need money and EVELYN told me that it is just purely photo modeling shoot, I agreed with her. At around 11:30 in the morning, I together with EVELYN went to Gaisano Tabunok, and we met the foreigner;
5. That we went to Pook, Talisay Beach. When we arrived thereat, MIKE got some dress and sandals from his bag and instructed me to changed clothes and after that he started taking pictures of me. We ended at around 1:00 in the afternoon and he handed me Php 500 as payment;
6. That on January 12, 2011 at around 10:00 in the morning, EVELYN told me that MIKE wanted to see me. EVELYN picked me up at around 11:30 in the morning. We met MIKE at Gaisano Tabunok; *Beim Stammbisch im Ayala Kaufhaus mit Evelyn*
7. That MIKE brought me and EVELYN to the city near Sto Nino Church. He instructed me to put over into my dress the long dresses he brought with him and he started taking pictures of me. He gave me Php 500.00 as payment. He also gave us NOKIA 3310 cellular phone;
8. That EVELYN called me up on the following week and told me that MIKE texted him and wanted to met me. Last January 19, 2011 at around 11:00 in the morning, EVELYN picked me up and we went to Gaisano Tabunok to met MIKE. He brought us to Queensland Hotel, Talisay, Cebu.
