Page 5.) Statements from Atty Pabriaga

1.) She (Jedidah Hefi) was one of the NBI Agents who rescued the Complaints on February 22, 2011 at Queensland Hotel Talisay. Illegal Arresting

It is also the February, 22nd, 2011 and not anymore the February, 2nd, 2011. Nobody claim it? Not the Judge Sarmiento, Not the Prosecutor Atty Torrovelo, Not the Private Prosecutor Suarez - Pabriaga, Not the NBI and also Not NBI Agent Jedidah Hefi.

In all affidavits from Evelyn (Asintista, Asintista or Macasling), Jenny Baran, Teofilo Catayas, NBI (Jedidah Hefi and Bernad dela Cruz and also in all court documents are set and noticed the February, 2nd, 2011. In all this documents are there also three (3) different Evelyns and two different days, when I should rape Jenny Baran (January, 19th, 2011 and January, 26th, 2011)

Why the NDI didn't arrest me on the parking area?
 When the two women Soared my car (without my per-

Because Evelyn text NBI a message and open the door for them.

Why NBI wait 30 minutes? It's not a "rescue operation" and also no "danger in delay". They make a picture of my car with Bernael dela Cruz on it. You can see ^{this picture} in the file. NBI has time to take picture during a rescue operation with danger in delay?

In the NBI affidavit the NBI Agents said, that ... the team rushed up to Room ... and now the NBI said that that the door was already open. What now?

Where are the fingerprints on the camera of me? Where are the evidence that the camera and the other things are my stuff? There is no evidence.

I should do in the 30 minutes → bring one big carton, 4 plastic bags, one sport bag, a camera, a videocamera several tripods, light etc alone to the room 24. The two women shave their pubic hairs. Diers on other clothes and remove them, cosmetic their faces and pose for few pictures? That all in 30 minutes?

The court are not shy to believe this?

Q: Did you not coordinate with the hotel management?

A: No, Your Honor. (Page 13.)

Why not? ~~Das HBT~~ The NDI could not know in what
room I am? Why the NDI didn't ask the hotel personal
after the arrest? If I am often here or like this?
Is this not police work after?

Page 13.)

The NDI didn't coordinate with the hotel management.

From where they know then in what room Jam? The parking lot lead to four rooms and a other door leads to the hallway what lead to round 100 rooms. What a coincident that the NDI pick up the right room from round 100 possibilities. The court is not shy to believe this lies? The NDI know the right room, because Evelyn text it them with the cellphone.

Why the NDI didn't ask the Hotel management or the personal? This are witnesses. The police usually ask witnesses after arrest. The NDI didn't, because it will proof the Set Up then.

In the NDI Affidavit they said, "the team rushed up the room". Can mean the NDI "break into" (Atty. Pabriaga) or the NDI "rushed" (NDI Affidavit), without to destroy the door? There are so many statements without exact proof, - how the door was open, - from where the NDI knows what room it was, - what time and so on.

The NDI don't document the arrest? The NDI is really a police? Why the NDI don't ask after the arrest

The NBI even planted the four blankets (blue, white, yellow
and green). Where ^{are} this blankets on the picture from Feb,

now two different arresting days.

On the next few pages the NBI shows clothes, shoes, etc...
but the NBI can not show even one memory card, where
I should make picture from the two women.
They bring in a Foto CD from the german police
